TERMS. PLEASE READ CAREFULLY:

- A. All items are offered "as is" & "where is" with absolutely no warranty of any kind, including merchantability and/or fitness for a particular purpose.
- B. Bidders are responsible for being knowledgeable of what they are bidding on, and Trittech Auctions, Inc. accepts no responsibility for the description, year of manufacture, make, model, serial number, etc. of the lots being listed for sale. Bidder accepts full responsibility for such knowledge and bidding.
- C. While bidders may bid on more than one lot, no groupings will be allowed unless it is for all lots as a grouping. Example, if bidder bids on 5 lots and is only successful on 3, then the bidder must take those 3 lots and shall not be allowed to reject the lots on which they have successfully bid. No exceptions!
- D. To receive best value for our client, bidders are encouraged to bid on all lots as a package. Therefore, after bids are opened and posted individually, they will be totaled. If any package bid on all lots exceeds the total of individually bid lots, the greater amount may be accepted. Please see paragraph "M" concerning the Multi-Tier racking system.
- E. It is the banks intent to sell this equipment at the bid opening to those who have bid according to terms. However, the bank retains the right to accept or reject any and/or all bids.
- F. Bidders are encouraged to submit payment for each lot individually. However, if that is too inconvenient, Trittech Auctions, Inc. will retain full payment and upon clearing of that payment will refund the amount due bidder for those lots on which the bids were unsuccessful.
- G. All bids must be accompanied by payment in full by cash, cashiers check(s) or check(s) accompanied with proper I.D.. No other form of payment will be accepted. Payment must include Kentucky Sales Tax of 6% in addition to the amount of the bid. If non-taxable (purchased for resale) bidder must provide complete and signed documentation acceptable to the auction company with bid. Only resale exemptions will be accepted.
- H. To be eligible to bid, all prospective bidders must register at the site on inspection day, Monday, November 27, 2006. The site will be open from 10:00 a.m. until 6:00 p.m. (EST) for inspection and registration.
- I. Bidders must be present at the bid opening at 1:00 p.m. (EST) on Tuesday, November 28, 2006. The site will be open from 11:00 a.m. until 1:00 p.m. (EST). At 1:00 p.m. (EST) no further bids will be accepted and the opening of the bids shall begin.
- J. In the unlikely event of a tie bid, an actual auction will be held between those parties only. The successful bidder must then be ready to pay the additional amount according to the payment terms. Bidders are, therefore, encouraged to make their bids such that they are not likely to be duplicated.
- K. Successful bidders payments will be retained. Unsuccessful bidders payments will be returned immediately (except as noted in paragraph F).
- L. All successful bidders must remove their lots on auction day (we will stay open until 5:00 p.m. [EST]), or on Wednesday, November 29, 2006 between 9:00 a.m. and 4:00 p.m. (EST).
